## What information do we collect?

The personal information we collect might include your name, address, email address, IP address, and information regarding our product usage, what pages are accessed and when.

### How do we use your information?

We may use your information to:

# Who can access your information?

However, when we use third party service providers, we disclose only the information that is necessary to deliver the service. We have a contract in place that requires them to keep your information secure, they will not use it for their own direct marketing purposes.

We may transfer your personal information to a third party as part of a sale of some or all of our business and assets to any third party or as part of any business restructuring or reorganisation, or if we're under a duty to disclose or share your personal data in order to comply with any legal obligation. However, we will take steps with the aim of ensuring that your privacy rights continue to be protected.
